LOYAL STUDY UPDATE

FROM YVETTE SHIPMAN

Loyal, a clinical-stage animal health company developing longevity drugs for dogs, has announced that the FDA's Center for Veterinary Medicine has accepted the Reasonable Expectation of Effectiveness (RXE) section of its conditional approval application for LOY-002. The drug aims to extend the lifespan of senior dogs and maintain their quality of life as they age, building on the company's previous RXE acceptance for a longevity drug specifically targeting the short lifespan of large breed dogs.

This is the Loyal Study that my Australian Shepherd Gypsy is in. She has been in the Loyal study for almost a year now. It is a 4 year commitment. She is either receiving the daily pill LOY-002 or a Placebo. Gypsy is 12.5 years old and doing good so far. Her next Study Vet visit is in June.



CLASS & MEMBERSHIP FEE CHANGES

The class fees will take effect with the June-Dec second half schedule.

All 6 week classes such as rally, tricks, and puppy will stay the same: \$100 Non-Members and \$50 Members

TRIBUTE TO LEE JACKSON

In memory of Lee Jackson, a devoted figure in the dog training community and a cornerstone of the Youngstown All Breed Training Club, we pay tribute to a man whose dedication and passion for the sport knew no bounds.

Lee Jackson's journey with the Youngstown All Breed Training Club began amidst humble beginnings, where a group of like-minded individuals gathered at Pioneer Pavilion in Mill Creek Park to train their dogs. Lee's commitment to the club was unwavering, and he spared neither effort nor expense in ensuring its vitality. As the club evolved, so did Lee's role within it, eventually earning him the title of "Mr. Youngstown All Breed." For an impressive 18 years, Lee served as the president of YABTC, leaving an indelible mark on its history.

But Lee's influence extended beyond the confines of YABTC. As president of the Mahoning Shenago Kennel Club, his leadership and vision shaped the broader canine community. His expertise as an AKC judge brought him national recognition, culminating in the prestigious 1977 Midwest D'Ambris award, a distinction sadly bestowed posthumously.

Lee's love for dogs was a family affair, shared with his wife Kay, with whom he competed in obedience trials with Dachshunds and Belgian Sheepdogs. Kay's tenure as Trial Secretary underscored the Jacksons' collective commitment to canine excellence. Their dogs, three of whom earned the title of Companion Dog, were testaments to their skill and dedication.

Yet, amidst his many achievements, Lee was known for his irrepressible sense of humor, exemplified by his decision to register one of his wire-haired Dachshunds with the name "DAMMIT."

In March of 1978, in honor of Lee Jackson, the first Lee Jackson award was given in tribute to him and has become a yearly tradition of YABTC. This award is given to an outstanding and dedicated person who embodies Lee's spirit of devotion and excellence.

To some who knew Dorothy, she was your second mother; or maybe in her later years, a second grandmother. To everyone who knew her, Dorothy Keck was a mentor and friend. She loved her dogs, had a great eye for a good one, and just embodied good sportsmanship.

AKC AGILITY COURSE TEST ACT LEVELS 1 & 2 along with ACTJ LEVELS 1 & 2

Check-in will begin at 9:30 AM

Dogs must be on lead or securely crated when not in the ring. Fees: \$20/run pre-entry (by May 11), Day of Show entries \$25 for 1st run, \$20/run additional runs (includes \$5 AKC recording fee). Entry Limit: 100 runs.

Running order: All Times are approximate and depend on how long it takes to get courses built and the number of participants. Running all classes 4-24" (Small to Tall). There are a total of 8 classes to enter.

8:00AM Take down original Course and build courses for ACT1 and ACT2

9:30AM Check-in begins

10:00AM Run ACT1 (Round 1) Max Course Time 60 seconds

10:30AM Run ACT1 (Round 2)

11:00AM Award ribbons for ACT1, Adjust courses for ACT2

11:30PM Run ACT2 (Round 1) Max course Time 70 seconds

12:00PM Run ACT2 (Round 2)

12:30PM Award ribbons for ACT2 and Build course for ACT1J

1:30PM Run ACT1J (Round 1) Max Course Time 50 seconds

2:00PM Run ACT1J (Round 2)

2:30 Award Ribbons for ACT1J and Build Course for ACT2J

3:30 Run ACT2J (Round 1) Max Course time 60 seconds

4:00 Run ACT2J (Round 2)

4:30 Award Ribbons for ACT2J

5:00 Take down ACT courses and Rebuild Agility Course

Green flat ribbons will be awarded to qualifiers. Rosettes will be awarded to Title earners. No placements.

The Agility Course Test (ACT) is an entry-level agility event designed to introduce beginning dogs and handlers to the sport of agility. Any dog that has not earned an AKC agility title is eligible. ACT Level 1 is open to dogs that have not earned any AKC agility titles. The course will have 10-12 obstacles: 5' aframe, table, tunnels, and jumps (no spread jumps); tire & panel jumps are allowed but not required.

ACT Level 2 is open to dogs that have not earned a title in any AKC Agility class except an ACT1 title. Level 2 courses have 11-13 obstacles, including all of the obstacles allowed in Level 1 plus the teeter, 6 weaves, tire, and 1 spread jump (triple, double, or broad); the dogwalk is allowed but not required.

ACT1J is a jumpers course. The course will have 10-12 obstacles including Bar jumps, panel, tire, and a max of 3 tunnels. ACT2J has 11-13 obstacles and includes the ACT1J obstacles plus 6 weave poles and a max of 1 spread jump.

Refusals & Run-outs are not judged in any of the 8 classes. More than 3 attempts at an obstacle will result in an elimination. The rest of the faults are the same as in the regular agility classes. All passing scores can be under the same judge. Only one dog in the ring at a time.

Dogs may be entered at any of the following jump heights: 4, 8, 12, 16, 20 or 24 inches, handler's choice. A jump height card is not required. Dogs will not be measured.

If you pass both ACT Level 1 tests (2 Qualifying runs earn the title) you may move up and enter Level 2 on the same day. You may also begin at Level 2. <u>Dogs must be 15 months or older</u> and meet the requirements for a regular AKC agility trial (Chapter 1, Section 3), except they do not need to be registered with AKC.

Dogs that are not AKC registered may participate and their performance will be recorded by the AKC under a temporary recording number. This temporary number will be emailed to the owner and must be used when entering subsequent ACT events; it may not be used for other AKC events.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents, event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge or ACT Evaluator, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. In order to acquire the ACT1 or ACT2 title certificate and have the title added to a dog's record, the dog must be registered/listed with the American Kennel Club. **AKC Canine Partners**sm applications may be accepted at the event and submitted to AKC with the event's results.

Dogs that are not AKC registered/listed may be registered at a later date and receive theirACT title at that time.

Dogs listed in the **AKC Canine Partners**sM program should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler Number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
